



## CPP20212 Certificate II Security Operations

### What is the course about?

This qualification is at the entry level that meets the national licensing requirements in the security industry. It is designed to meet the training requirements for licensing as **unarmed guards** in Queensland.

Successful completion of this program will allow you to apply to the Queensland Office of Fair Trading for an unrestricted Security Officer licence, and provides the pathway to higher level training programs, such as Certificate III in Security Operations.

### Job roles

A current security officer (unarmed) licence holder, can apply for security positions such as

- static guard
- mobile patrol officer
- Construction Site
- shopping centres
- resorts, universities
- schools and a multitude of other areas

### How long does it go for?

This course requires completion of 12 units of competency over 5 days.

### Where can it take me? What can I do next?

As a graduate of this course you are eligible to enrol in: Certificate III in Security Operations

### What will I study?

Units of Competency

To complete this qualification, participants must complete 7 core and 5 elective units.

### Core Units

- CPPSEC2001A Communicate effectively in the security industry
- CPPSEC2002A Follow workplace safety procedures in the security industry
- CPPSEC2003B Work effectively in the security industry
- CPPSEC2004B Respond to security risk situation
- CPPSEC2005A Work as part of a security team
- CPPSEC2006B Provide security services to clients
- HLTFA311A Apply first aid

### Elective Units

- CPPSEC2017A Protect self and others using basic defensive techniques
- CPPSEC2011B Control access to and exit from premises
- CPPSEC2012A Monitor and control individual and crowd behaviour
- CPPSEC2014A Operate basic security equipment
- CPPSEC2015A Patrol premises

### Do I need to have completed previous study?

There are no prerequisites for entry into Cert II in Security Operations. Participants are required to be competent in written and spoken English and will undertake a Language, Literacy, and Numeracy test prior to commencing the training.

### **Assessment**

Competency based training is concerned with assisting people to gain specific competencies relevant to the purpose of their program of study. A participant will be assessed by performing set tasks at specified standards, under prescribed conditions. A range of assessment methods will be used to enable participants to demonstrate competency.

### **Recognition of Prior Learning**

If what you have learned at work, from other programs, courses, from life experience or training provided at work is relevant to this program, you may be entitled to gain subject credits or exemptions. The College is obliged to recognise the AQF qualifications and statements of attainment issued by other registered training organisations. For further details contact the Administration Officer.

### **Eligibility**

To be eligible for a licence, you must:

- be 18 years or older
- have no recorded conviction of a disqualifying offence within the previous ten years.
- have no unrecorded finding of guilt of a disqualifying offence in the previous five years
- not be considered a risk to public safety
- have successfully completed the training

### **Course Fee**

The fee for Certificate II in Security Operations as a self-funded student is \$329.
